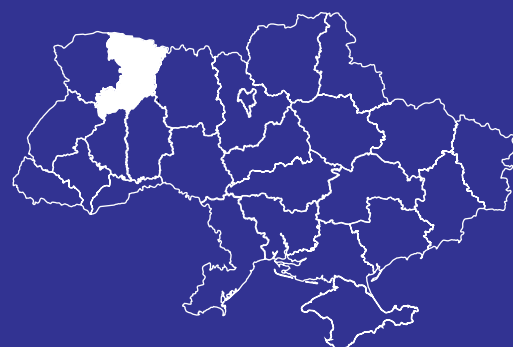

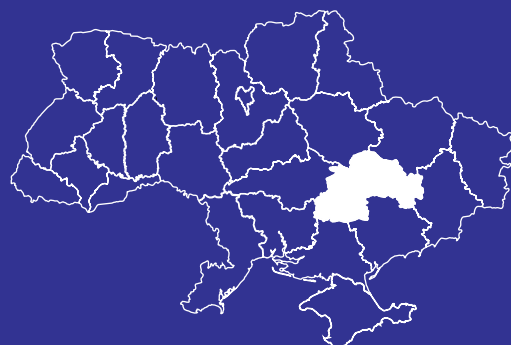

From the field and forest to harvesting and through production, Amethyst-Ole strives to assure food safety standards and effective tracking of both its organic and conventional products.
